INTRODUCTION

In order to operationalize the ABS Clearing-House, Parties (and Non-Parties using the ABS Clearing-House) need to nominate a single publishing authority (PA) to clear national records prior to publishing them in the ABS Clearing-House.

The duties of the National Focal Point (NFP) could also be expanded to incorporate the role of the publishing authority. The publishing authority can prepare draft records and publish them directly, and can also designate one or more national authorized users (NAUs) to assist them in preparing draft records for publication in the ABS Clearing-House on behalf of their country.
