TO SPECIFY THE TASKS OF THE NATIONAL CLEARING-HOUSE ON ACCESS AND FAIR AND EQUITABLE SHARING OF BENEFITS ARISING FROM THE UTILIZATION OF GENETIC RESOURCES.-

THE MINISTER OF ENVIRONMENT, NATURE PROTECTION AND SUSTAINABLE DEVELOPMENT,

HEREBY ORDERS AS FOLLOWS:

CHAPTER I
GENERAL PROVISIONS

ARTICLE 1.- (1) This Order specifies the tasks of the National Clearing-House on access and fair and equitable sharing of benefits arising from the utilization of genetic resources, abbreviated "ABSCH".

(2) It is pursuant to the provisions of Section 35 of Law No. 2021/014 of 21 July 2021 to govern access to genetic resources, their derivatives, traditional knowledge associated with genetic resources and the fair and equitable sharing of the benefits arising from their use.

CHAPTER II
TASKS

ARTICLE 2.- (1) The National Clearing-House on Access to Genetic Resources, their derivatives and traditional knowledge associated with genetic resources and the fair and equitable sharing of benefits arising from their use (ABS) shall be the virtual platform for sharing information relating to ABS.

As such, it shall be particularly responsible for:

- providing a centralised platform for disseminating information on activities relating to the ABS process;
- setting up and managing the database on genetic resources and traditional knowledge associated with genetic resources;
- promoting greater transparency of the ABS mechanism.

(2) The ABSCH shall be managed by a Focal Point appointed by the Minister in charge of the environment.

CHAPTER III
MISCELLANEOUS AND FINAL PROVISIONS

ARTICLE 3.- The ABSCH Focal Point shall submit an annual activity report to the Minister in charge of the environment.
